

# Alameda County Clean Slate Clinic

*A Project of the East Bay Community Law Center*

The East Bay Community Law Center's Clean Slate Clinic provides free legal help to eligible individuals who are seeking to clean up their criminal records. We can provide general information about convictions in all California counties and may represent you or help you represent yourself in your Alameda County cases.

Eligible clients:

1. do not have any pending charges;
2. are not on parole or have completed at least half of their probation term; and
3. have their Alameda County or California State Department of Justice RAP sheets (Record of Arrest and Prosecution).

In order to receive a free legal consultation, you must have a RAP sheet and know whether you owe fines, fees, or restitution on your criminal cases (instructions below).

The Clean Slate Clinics are staffed by attorneys and supervised law students  
Walk-ins welcome. All legal services are free of charge.

## GETTING YOUR RAP SHEET AND CHECKING ON YOUR ACCOUNT

### ALAMEDA COUNTY RAP SHEETS

Get a copy of your Alameda County RAP sheet **only** if you know you do not have any arrests or convictions outside of Alameda County. You may obtain a copy of your Alameda RAP sheet by going in person to:

The hours are 8:30 am to 3:30 pm. The cost is \$25, cash only. You must appear in person as you will be fingerprinted. The process takes about one hour. Clear any outstanding warrants before appearing.

### CALIFORNIA RAP SHEETS

For a RAP sheet that reports all of your arrests and convictions in every county in California, you must obtain a RAP sheet from the California Department of Justice. Call the East Bay Community Law Center (510-548-4040) and ask for a DOJ rap sheet information packet.

### FIND OUT IF YOU OWE FINES FEES & RESTITUTION IN ALAMEDA COUNTY

If you owe, or might owe, fines, fees, or restitution on your criminal case(s), go to the Alameda County Central Collections Department at 1221 Oak Street, Room 249 in Oakland or call (510) 208-9900 and ask, "Do I owe any outstanding fines, fees, or restitution on any of my Alameda County criminal cases?" If you do, please pay or initiate a payment plan to demonstrate to the court your commitment to fulfilling your obligations. Ask for a receipt and bring all receipts with you to the Clean Slate Clinic.

**From I-880 San Jose, Fremont, Hayward**

Continue on I-880 North to the Oak Street exit. At the light turn right and drive up Oak five blocks to 12th Street. Courthouse is located at 12th and Oak Streets.

**From I-580**

Follow I-580 to the I-980 connector. Continue on I-980 and exit on Jackson Street, turn left at the first light and drive up Jackson to 13th Street and make a right turn. The Courthouse is two blocks from Jackson at 13th and Oak Street.

**From I-80 San Francisco, San Mateo**

From the Bay Bridge/Berkeley-Emeryville area, follow directions to I-580 to the I-980 connector. Continue on I-980 and exit on Jackson Street, turn left at the first light and drive up Jackson to 13th Street and make a right turn. The Courthouse is two blocks from Jackson at 13th and Oak Streets.



**BART-Fremont Line**

Exit at the Lake Merritt station on 9th and Oak Street. The Courthouse is three blocks east of the Bart station at 12th and Oak Streets.

**Parking**

The County parking garage, Alcopark, is located on Jackson Street between 12th Street and 13th Street. The rate is \$6.00 per day. Proceed to the top floor.

From I-580 and I-80, follow instructions above. From I-880 South, follow directions to 12th and Jackson Streets. Parking garage is on Jackson Street between 12th and 13th Streets.

**Directions to Eden Area Multiservice Center  
24100 Amador Street, 3rd Floor, Hayward, CA 94544**

**From I-880 Northbound from San Jose/Fremont**

Exit onto W Winton Ave. Turn right at Amador St.

**From I-880 Southbound from Oakland/San Francisco**

Take the exit onto I-880 S toward San Jose/San Mateo Bridge. Exit onto W Winton Ave. Turn right at Amador St.

**From I-580**

Head west on I-580 W. Slight left at I-238 N (signs for I-238/I-880). Take the exit onto I-880 S toward San Jose/San Mateo Bridge. Exit onto W Winton Ave. Turn right at Amador St.

**BART-Fremont Line**

Exit at the Hayward station. Head southwest on B St toward Grand St. Turn left at Grand St. Turn right at D St. Slight right at Winton Ave. Turn left at Amador St.
